The Wallace Town Council held its regularly scheduled monthly meeting on Thursday August 15, 2024, at 6:00 pm in the Council Chambers at the Town Hall.

Mayor Jason Wells called the regular meeting to order with a quorum of the governing body members present and Council Member Tasha Herring gave the invocation.

The Pledge of Allegiance was recited.

Adoption of the Agenda

Mayor Wells asked if there were any additions or changes to the agenda. Town Manager Rob Taylor asked to add a Resolution Accepting State Revolving Loan for the Maple Creek Force Main upgrade.

Council Member Herring made a motion to adopt the agenda as amended, seconded by Council Member Frank Brinkley and approved unanimously.

Public Comment Period

There were no comments.

Consent Agenda

Mayor Wells called for discussion of the minutes from the July 11, 2024 regular meeting. There being no additions or corrections, Council Member Francisco Rivas-Diaz made a motion to

approve the minutes as submitted. The motion was seconded by Council Member Herring and approved by unanimous vote.

Council Member Brinkley made a motion to approve the releases that was seconded by Council Member Penny Thorn and approved unanimously.

Old Business

Establish Public Hearing for Rezoning

Planning Director Rod Fritz asked the Council to establish a public hearing for the September 12 meeting for a rezoning request. The public hearing was not held as originally advertised because of Tropical Storm Debby.

Council Member Brinkley made a motion to establish a public hearing for rezoning on Thursday, September 12, 2024 after 6:00pm which was seconded by Council Member Rivas-Diaz and unanimously approved.

Services of NC Main Street and Rural Planning Center Resolution

Manager Taylor said at the last meeting the Council agreed to participate in the development of an Economic Development Strategic Plan with the assistance of NC Commerce's Rural Planning division which requires the adoption of a resolution.

Council Member Herring made a motion to adopt A Resolution Requesting The Services Of NC Main Street And Rural Planning Center that was seconded by Council Member Thorne and approved unanimously.

Tentative Award of Road Realignment and Construction-Airport

Manager Taylor stated that the next step in the expansion of the Wallace-Pender Airport is the road realignment and construction. Barnhill Contracting Company was the lowest bidder and the project can tentatively be awarded by the adoption of Resolution 24-25-02.

Council Member Brinkley made a motion to adopt a Resolution Of Tentative Award that was seconded by Council Member Rivas-Diaz and approved by unanimous vote.

Tentative Award For Lighting and Runway Rehabilitation

Manager Taylor said bids were received for the rehabilitation of the existing runway and new runway lights with the low bidder being Fred Smith Company. The project can tentatively be awarded through the adoption of a resolution.

Council Member Brinkley made a motion to adopt Resolution of Tentative Award 24-25-03. Council Member Thorne seconded the motion, and it was approved by unanimous vote.

New Business

Budget Amendment to Purchase Vehicle

Manager Taylor remarked that rather than move a vehicle from Public Services to Administration for travel that a vehicle be purchased which requires a Budget Amendment.

Council Member Rivas-Diaz made a motion to approve Budget Amendment 25-1 which was seconded by Council Member Brinkley and unanimously approved.

Budget Amendment for Grist Mill Project

Manager Taylor reported that the Town has been awarded an additional \$50,000 toward the restoration of the Boney Mill Grist Mill using the additional funds to improve the floor.

Council Member Thorne made a motion to approve Budget Amendment 25-2. The motion was seconded by Council Member Herring and approved by unanimous vote.

Capital Project Ordinance for StRAP (Streamflow Rehabilitation Assistance Program) Grant

Manager Taylor said the Town had applied for a \$350,000 grant for Boney Mill Pond, Nicholson Creek and the small pond at Farrior Park and received a partial grant in the amount of \$115,000 for the Nicholson Creek portion of the application. He asked the Council to approve a Capital Project Ordinance to track revenues and expenditures for this project.

Council Member Brinkley made a motion to approve Capital Project Ordinance 25-01 StRAP Grant Nicholson Creek/Farrior Park that was seconded by Council Member Rivas-Diaz and unanimously approved.

Resolution Accepting NCDEQ (North Carolina Department of Environmental Quality) Revolving Loan

Manager Taylor stated that in August 2023 the Town requested a loan for the construction of the Maple Creek Force Main project which was approved by the LGC (Local Government Commission) and asked for a resolution accepting the loan.

Council Member Herring made a motion to adopt Resolution Accepting State Revolving Loan 24-25-04. The motion was seconded by Council Member Brinkley and approved unanimously.

Financial Reports

Finance Director Trollinger said he is wrapping up posting entries for FY 2023-24 for the auditors and closing out the fiscal year.

There being no further business to discuss Council Member Brinkley made a motion to adjourn. The motion was seconded by Council Member Herring and approved by unanimous vote.

Capital Project Ordinance 25-01 StRAP Grant Creek/Farrior Park

WHEREAS, the Town of Wallace received a \$115,000 allocation from StRAP program administered by North Carolina Department of Agriculture for stream restoration on Nicholson Creek and the small pond at Farrior Park, and;

WHEREAS, the Town desires to establish a capital project ordinance to track the revenues and expenditures for the project;

NOW, THEREFORE BE IT ORDAINED by the Town Council of Wallace that pursuant to section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following Capital Project Ordinance 25.01 is hereby established and adopted:

Section 1: The Project authorized for the stream restoration of Nicholson Creek and small pond at Boney Mill.

Section 2: The officers of this unit are hereby directed to proceed with the capital project within the terms of the board resolution, and the budget contained herein.

Section 3: The following initial amounts are appropriated for the project:

RESOLUTION ACCEPTING STATE REVOLVING LOAN Resolution 24-25-04

WHEREAS, the North Carolina Clean Water Revolving Loan and Grant Act of 1987 has authorized the making of loans and grants to aid eligible units of government in financing the costs of construction of wastewater treatment works, wastewater collection systems and water supply systems, water conservation projects; and

WHEREAS, the North Carolina Department of Environmental and Natural Resources has offered a State Revolving Loan in the amount of \$1,884,219 for the Maple Creek lift station upgrade, force main and gravity sewer system expansion along River Road; and

That the Town has substantially complied or will substantially comply with all Federal, State and local laws, rules, regulation, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.
